Community Developments GLEANINGS from MEETINGS

Montgomery County Civic Federation: The June meeting heard presentations from two departments of the County. The Department of Permitting services addressed issues such as : How to gain input when a yellow sign indicates new construction planned; Protection for a neighbor when a demolition is planned; Permit needed for driveway construction, or who to contact for tree removal in the public right of way (the area of your yard within approximately 20 feet of the road edge); Who to call if you feel construction is not following an approved plan; What to do if muddy or excessive water runoff from a construction site occurs. The Office of Consumer Protection advised about the New Home Warranty Program and the Board of Registration of builders. This is an excellent office to contact regarding differences that arise between residents and businesses.

The July meeting is the Fed's annual occasion for making plans for its activities for the year starting in September.

Mid-County Citizens Advisory Board: June's meeting dealt extensively with the proposed development on the Indian Spring Country Club site of 773 homes and was conducted by staff members of the Planning Board. The development, currently known as Poplar Run, will be the subject

of a hearing before the Montgomery County Planning Board on September 7, 2006. There is a possibility that the hearing might continue on September 14. This is a very large project, covering 308 acres, and will have a major impact on this area. Citizens from a number of communities will be testifying about this matter, including myself. We advise attention to this activity. The Board's July meeting recognized the service rendered to the community by several outgoing members, and welcomed incoming Chairman, L. Blaine Charak, and Vice-Chair, Walter Booth. Aide to Marilyn Praisner, Joy Nurmi, reported on the new Workforce Housing Bill.

Office of Zoning and Administrative Hearings:

This reporter, as well as other members of communities nearby, testified before the Hearing Examiner, Ms. Francoise Carrier, in regard to the Kirby-Vedanta project at Homecrest and Bel Pre Roads. While acknowledging that the development has undergone a large improvement, there are still several issues that citizens felt needed resolution. Ms. Carrier felt that her decision on these issues would be forthcoming in approximately 60 days. That decision goes then to the County Council for a final decision. We will keep you posted.

Kennedy High School:

COMMENCEMENT: On June 1, more than 300 Kennedy High School received their diplomas. The featured speaker was the Surgeon General of the United States, Vice Admiral Richard H. Carmona. Kennedy students have been accepted by more than 120 universities which include nearly every major institution of higher learning in the Washington area, nearly every institution in the state of Maryland, a number of Ivy League schools, the US Naval Academy, and other colleges throughout the country, several in Canada and one in England.

ACHIEVEMENTS: Kennedy is proud that the recent emphasis on students taking more challenging Advanced Placement classes has resulted in our school, along with all other Montgomery County public high schools, being in the top 3% of American high schools on Newsweek magazine's Challenge Index. In fact, Kennedy experienced a dramatic improvement from last year's position of 658 (out of 27,500 high schools) to this year's position of 443 which raised it above nine other

MCPS schools. Also, the average SAT score for seniors has improved for the second year in a row.

Dolphins Complete 3-Year Rise from Bottom of C Division to Become the PMSL's Number 2 Team

The Dolphins returned to 'A' Division this season after a six year absence. The Dolphins arrived in 'A' as the undefeated 'B' Division champions, but expectations were low. The previous year, the previous 'B' Division champion had gone winless in 'A' Division. The Dolphins entered this season hoping for 1 or 2 wins. After all, it had been more than 10 years since the team's last winning season in 'A' Division.

However, someone forgot to tell all of this to the swimmers and coaches. The Dolphins surpassed all expectations, going 4-1 in the regular season to tie for first place going into the Divisional meet. The Dolphins placed third in the Divisional meet and finished as 'A' Division runner-up, overall the 2nd best team in the 5-county, 40 team Princemont Swim League, placing ahead of several much larger, 200+ swimmer teams! It's an exceptional performance for a 'closed' team whose competitors can openly recruit for the best swimmers.

That accomplishment is the latest in an incredible run by the Dolphins over the past 3 seasons. In 2003, the team went 1-4 in B Division and finished dead last in the B Divisionals meet. In 2004, they started as last seed in C Division, nearly falling to D Division for the first time in Dolphins history.

The meets in C Division during 2004 were very close. In several meets, the Dolphins won only by swimming clean with fewer DQs than their opponent. Despite the close meets, the coaches and kids still found a way to win every meet. They went undefeated in 2004 and won the C Division championship.

In 2005, the team moved up to B Division, hoping to win at least a few meets. That would be success after 4 previous consecutive losing seasons in B Division. Once again, every meet was close. The Dolphins needed to fill the lanes, swim cleanly, and post best times to surprise their opponents each week. The team went 5-0 in the regular season but still was only seeded third at B Divisonals.

The coaches and kids surprised us all again. At the 2005 B Divisionals, 17 of our first 20 swimmers posted best times for the season, starting a wave that ended with the Dolphins' 2nd consecutive undefeated season and a B Division Championship.

So the Dolphins moved up to A Division, seeded last again. The first meet against 3-time A Division champion Belair Bath & Tennis (BBT) was the first sign of something special this season. Instead of being blown out as expected, the Dolphins were competitive. The question was in the air, if the Dolphins could be competitive against BBT, what did that mean for the other A Division teams?



beat all other A Division teams. They finished as A Division runner-up, a long way from the bottom seed of C Division at the start of 2004.

Long-time Dolphins fans sometimes talk about the old days of the streak, when the Dolphins won 54 straight meets over 11 years. What the Dolphins have accomplished these past three years is just as impressive! It's a feat, consecutive Division championships while rising from lower Divisions, which those great old teams never matched. Our Dolphins have begun a new streak!!

The Dolphins were also awarded the League's Saum-Hilton Award. This award, named in honor of two of the founder's of the Princemont Swim League, is given each year to one of the two smallest teams in each Division. It is awarded to the team that has improved the most relative to its initial seeding but did not win the Division. It's the league's official recognition of the Dolphin's accomplishments in rising from 6th seed to finish 2nd in 'A' Division.

The 'A' Divisionals meet also saw Takoma Park set a new league record in the Girls Mixed Age Freestyle Relay. The record had stood since 1984 and was held by the Strathmore Bel Pre team of T. Long, J. Martinson, M. Smith and Dolphins Head Coach Terry Kominski. This was Terry's longest standing PMSL record from her days as a Dolphins swimmer. Her sister Ruth still holds several PMSL records and Terry still holds several Dolphins and SBP Pool records.

Finally, the Dolphins capped their season with a win at the Cheverly Relays meet, defeating several teams including Takoma Park, who came in second at the 'A' Divisionals meet.

We now know. During the regular season, the Dolphins




