

Gleanings From Meetings + More

April Meetings

Montgomery County Civic Federation-

The April meeting concerned the County Fiscal Year 2013 operating budget of \$4.6 billion. Steve Farber, Chief of Staff for the County Council and Jennifer Hughes, Director of the Office of Management and Budget, were the presenters.

Highlights from their presentations:

- 1) The energy tax will not sunset.
- 2) Between 2000 & 2009, the County exceeded the amount necessary to meet the Montgomery County Public Schools Maintenance of Effort dollar amount by \$576 million. This amount then was added to the Maintenance of Effort base, which creates an enormous problem when the County no longer has the funds to meet this new school funding base. The State gives Montgomery County no credit for any past increases in education spending, and the county thereby suffers a financial hardship. On top of the maintenance of effort burden, potentially will come the County's share of public school employee pensions.
- 3) The police are slated to get 43 more officers, and libraries a 10% budget increase.
- 4) 8% of the County's budget is for debt service. Employee pensions are the largest portion of the budget.
- 5) County employees will receive a \$2,000 bonus, which will not count as salary and will not be a basis for future pay negotiations.

April's Community Hero Award went to David Lucia, coach of the Cheetahs, the county's special needs ice-hockey team. The coach pointed out that the team members were the true heroes. His description of the achievements of the group brought a large lump to this writer's throat, as it was extremely moving.

May Meetings

Civic Federation –

In May the meeting featured a program comparing natural grass sports fields with artificial turf fields. The latter are planned for all county high schools. Artificial turf fields pose some health threats that have not been well studied. The health issues arise from the use of pulverized rubber tire material used as cushioning and for keeping cleats from sinking into the backing. While artificial turf is considered more durable, there are significant costs involved with artificial and natural turf, so it is not clear which is the better value in the long term.

Come, See, and Use the New Steps to the Matthew Henson Trail

Great news! The Montgomery County Department of Transportation just replaced the wooden steps that provide access to the Matthew Henson Trail from Rippling Brook Drive.

History of the Rippling Brook Steps

The entryway to the Matthew Henson Trail, from the north side of Rippling Brook Drive is down a steep slope. In 1997, long before the Trail was built, Troop 96 Eagle Scout Armando Saltivora headed-up an effort to install wooden timber steps down the steep terrain. This allowed the Scouts, along with the neighborhood, easier access to the beautiful woods and the then unpaved trails. The steps greatly enhanced our community, and the garden timbers served the community well for 15 years. But, over the years, the steps decayed, a couple of the steps became loose, and using them became dangerous.

The Long and Winding Road to Replacement of the Steps

It took over a year in earnest to get the steps replaced. We begged and pleaded, did research, wrote letters, made phone calls, and argued and re-argued our case for the steps to be repaired or replaced and a handrail to be added. Several Montgomery County government agencies and offices turned us down for various reasons. Then, we turned to County Executive Ike Leggett.

May Meetings

State Highway Administration -- Georgia and Randolph Intersection

The State Highway Administration gave a presentation in mid-May on the schedule of the upcoming intersection change, where Randolph Road will be constructed so as to travel under Georgia Avenue. This project began in 1999 and will cost about \$63 million. Part of the funding for the project comes from Montgomery County, while the majority of the funding comes from the State. Construction of the underpass will begin shortly after completion of a new fire station. The fire station, now at the corner of Randolph and Georgia, will move, and will be located on the West side of Georgia Avenue, just North of the new Metro garage. Plans are that the underpass will be open in late 2016.

Streamlining Development

Also, another meeting on the same day, entailed 6 work groups discussing the process for real estate development approvals. Since the goal for the approval process is to protect the public interest, all aspects of a new development must be planned, so as to minimize the impact to the nearby and greater communities. The planning list includes: school capacity; sewer and water needs; the environmental impact, including stormwater; traffic with road capacity and pedestrian safety; transit needs; police and fire/rescue capacity; and recreation facility availability. Many county departments and the Planning Board approve various parts of each new development's plan. The approval process is long and involved. There will be more meetings like this one. The goal is to shorten the process so that new housing or new business development can be made available in a shorter time and with less expense.

Accessory Apartment

After many more months and more obstacles overcome, Mr. Leggett and the Montgomery County Department Transportation came through. In April, the steps were replaced and both entryways to the Trail were greatly improved.

The Well Designed New Steps and the Greatly Improved Entryways to the Trail.

The design of the steps, the entryway to the Trail on both sides of Rippling Brook and even the drainage system installed at the bottom of the steps are beautifully and thoughtfully designed.

Highlights of the Improvements include:

- Three tiers of not so steep stairs, with custom built handrails.
- For bicyclists, two tracks run the length of each tier of stairs. This allows bicycles to be walked up or down alongside the steps, and is a European design.
- On the opposite side of Rippling Brook, the entryway to the Trail has been improved for wheel chair accessibility from the street, and from the sidewalk.

• A black-top path connecting the stairs to the Trail, and connecting the street to the Trail on the other side of Rippling Brook was added. This replaced a dirt path which become muddy in rainy weather.

A Primer on the Strathmore at Bel-Pre Covenants - Part One

Over the years, the restrictive covenants on the properties at Strathmore at Bel-Pre have been the subject of much discussion among our residents. This article provides a summary and some history of these documents.

In September 1966, Levitt and Sons, Inc. filed a plat (a map) for a subdivision to be known as Strathmore at Bel-Pre. The subdivision consisted of 22 sections, running southward from Bel-Pre Road on the north and westward from Layhill Road on the east. The sections had their own plats laying out the streets and building lots for the entire subdivision. Of these 22 sections, plats were recorded for only 21 sections.

Accompanying some of these plats were recorded covenants and other documents. The primary documents were:

- a) Articles of Incorporation for the Bel-Pre Community Association, Inc.
- b) Supplemental declaration changing the name of the Bel-Pre Community Association to the Bel-Pre Recreational Association, (BPRA)
- c) Declaration of Covenants, Restrictions, Easements, Charges, and Liens (the BPRA covenant)
- d) Supplemental declarations bringing additional properties under the purview of the BPRA covenant
- e) a series of 12 Declarations of Covenants and Restrictions for 11 sections of the Strathmore at Bel-Pre subdivision (Land Use Covenants).

BPRA homeowners who need copies of the Bel Pre - Strathmore Covenants or other Bel Pre Rec. Assoc. Documents in order to sell their homes should eithers 1)contact the Civil File room in person. There is a cost for duplication. This office can be found on the first floor of the Circuit Court Building in Rockville. Refer to Civil Desk: Homeowner Records, HOA 268 filed on March 28, 1989, or 2) call Community Paperworks and ask for a resale package approximate cost \$75). Their phone number is (301) 309-8977.



The Strathmore Bel-Pre Civic Association started its membership listserve on March 7, 2010. In these first two years, the listserve has grown to 221 members, representing about 186 Civic Association member households. Since its inception, the listserve has averaged about 1 message per day, although there is wide variation around that average! \bigcirc



When the Civic Association decided to start a community listserve, the goal was to create an interactive channel for members to communicate. We also saw the listserve as a means to get news to the community more quickly than is possible with *The Bugle*. The listserve has met those goals and more.

Some popular uses of the listserve so far:

• Comparing notes with owners of the same house model on how to fix issues with that model. The most recent discussion concerned aluminum wiring originally installed in some models.

• Finding local service providers (painters, electricians, housecleaners, etc.) with a good reputation in the neighborhood

• Quickly sharing information about community developments such as the opening of the new Mid-County Recreation Center, potential plans for new Wal-Mart and Kohl's stores in Aspen Hill, progress on updating the Glenmont Sector Plan, etc.

• Sharing information about community emergencies such as last summer's drug raid and the recent fire at Peppertree apartments that destroyed the homes of some Georgian Forest Elementary School children.

• Organizing community action such as the recent efforts to prevent the Leisure World Post Office and Del Mercado Giant from closing . (the Post Office is staying, the Giant closed)

Metcalfe's Law says that the power of a network grows with the square of the number of users. Put another way, the value of a network like the Strathmore Bel-Pre Civic listserve will grow exponentially with every additional user. The Civic Association has some 750 households, so the listserve can be of great value to all of us.

Please do join, and do encourage your neighbors to join the listserv through their Civic Association membership, so that we can make our listserv an outstanding source of information and news for our community.

Thanks also to everyone for your support over these first two years!

The Articles of Incorporation of the Bel-Pre Community Association (later called the Bel-Pre Recreation Association, or BPRA) was the first document recorded by Levitt and Sons in advance of the planned construction of the community. The purposes for which the Corporation was formed and the business to be carried out by the Corporation were:

- (a) to promote the health, safety, and welfare of the residents by owning, acquiring, building and operating facilities for swimming and tennis
- (b) enforcing "any and all covenants, restrictions, and agreements applicable to the Common Areas and the residential lots (*the enforcement of which is not specifically and exclusively reserved to other*)". [emphasis author's]
- (c) to fix and levy assessments to operate and maintain the facilities in the Common Areas.

The balance of the Articles deal with the management of the Corporation and with the vote necessary to dissolve the Corporation (2/3 of the Lot Owners).



Bel-Pre Recreation Association Covenant

The Declaration of Covenants, Restrictions, Easements, Charges and Liens was recorded in 1968 and represents the covenant controlling the operation of the common areas, the swimming pool, and ancillary areas. The covenant consists of six articles.

Article I contains the definitions of the Declaration. It defines the Association (BPRA), the Properties, the Common Areas, the Lots, the Owners, and the members. Article II describes the property subject to the Declaration: existing property, additions to the property, and additions to the Common Areas. It should be noted that the Declaration permits the Owner of any property to become subject to the Declaration by applying and upon approval by the Association.

Article III describes the voting rights in the Association. Voting rights are limited to the Owner of the Lot of record. (Aside: renters are not entitled to vote) There is only one vote per Lot.

Article IV describes property rights in Common Areas. They include title to the Common Areas. In addition, the article describes the right of the Association to suspend membership for infraction of rules and regulations, the right of the Association to transfer the Common areas to a governmental body upon approval by the Membership, and the right of the Association to grant easements for utilities.

Article V provides for the creation of Assessments, annual and/or special, which are a charge on the land and a continuing Lien on the Lot. The article further describes the purposes of the assessments, the basis and purposes of the annual assessments, consideration of special assessments for capital improvements with such assessments requiring a 2/3 vote of the Members, voting in person or by proxy. Changes in the annual assessment require a 2/3 vote as well. The article defines the quorum needed to change the assessment as 60% of the voting members. The article continues with a section describing the duties of the Board of Trustees. The article concludes with the actions incumbent upon the Association if a Lot Owner fails to pay the assessment.

The last article contains general provisions, including the duration of the Declaration, rules and methods for changes to the Declaration, notice to the Members or Owners, and enforcement of the Declaration.

It should be noted that the Declaration applies ONLY to the Common Areas. Covenants for the lots are covered by a different covenant which will be described next. The entire Declaration can be obtained from the Maryland Land Records web site at www.MDLandRec.net.

When you get to that web site you must register to get a password for entry. When you have logged in to the site, you are taken to the Montgomery County Circuit Court page where you enter the Book No. (Liber) and Page No. (Folio). For the Declaration for the BPRA, the entries are: Liber 3721 Folio 339-351 These pages can be printed.

Part Two will discuss the Land Use Covenants, and will be in the next issue of *The Bugle*.
