

Annual Meetings

Please mark your calendars for two upcoming dates: November 19 and December 2.

The annual general membership meetings of the Recreational Association and the Civic Association both will be held on Thursday, November 19, at Bel Pre Elementary School, 13801 Rippling Brook Drive. Both groups will hold elections for seats on their governing boards. The Civic Association will meet from 7 pm to 7:30 pm, followed immediately by the Recreational Association. Quorum and Town Hall Meeting

The owners of 71 homes within the Recreational Association (who have paid their annual \$225 membership dues) must be present at the annual meeting for us to have a quorum. If we do not have a quorum at the November 19th BPRA meeting, we will have a follow-up meeting on Wednesday, December 2nd, at 8:00 pm to elect members of the Board of Trustees. If we don't need the follow-up meeting on December 2nd, we will hold a Town Hall meeting with a question/answer format like we did last year. So either way, save both dates on your calendar. **November 19 and December 2**.

Budget

You should have received a copy of the proposed BPRA annual budget in the mail, along with your official notice of the annual meeting. The Board of Trustees plans final action on the budget at its January meeting. We would like very much to get the input of everyone in the Association. The budget is our key planning document for the upcoming fiscal year, which runs from March 1, 2016 to February 28, 2017.

Financial Records and Budget Documents

We are now well along on moving from our paper-based financial processes to an electronic-based system. At the same time, monthly financial statements, annual audits, long-range planning studies, and adopted budgets from previous years are now available on the BPRA website at http://strathmore-belpre.org/bpra-governing-documents/ under the "Budget and Maintenance" heading.

Thank you to LARRY VAUGHT and RITA VAUGHT for their work in planning and implementing the new
processes; and to CHRIS JENNISON for the additions to the website. Also thanks to BOB BOWSER, whose 2014
BPRA Finance Committee laid the ground work for this change.

Pool Physical Plant

As I noted in the June issue, our pool will reach its 50-year mark in just a few years, 2019. Our 10-year facility study (available at http://strathmore-belpre.org/wp-content/uploads/2014/07/BeL-Pre-Pre-Pool -report-Final.pdf) identifies numerous parts of our recreational facilities that are reaching their life expectancy.



In August, an emergency replacement of the hot water heater was made. On the last day of the season, emergency repairs also were needed to replace a broken flange in the pool's pumping system.

• Thanks to the efforts of GREG MILLER, JOE MOELLER, CLARK BAUGHER (Georgetown Aquatics), and BILLY RUPERT in these emergencies, we were able to stay open every day of the season.



Concrete and Pump Room

We have issued an RFP for replacement of the three concrete pool deck slabs next to the roof of the pump room, to replace the associated drain system, repair and caulk other concrete slabs, and re-caulk the seams around both pools. This work should be completed before the start of next year's pool season.

Our next step is expected to be a review of the pool's filer system and a structural engineer re-evaluation of the pump room. To help set longer-range

priorities and to better develop a strategy to deal with the costs involved, we will be developing a multiyear capitol budget to supplement the BPRA's annual budget.



Update on Glenmont MetroCentre Developments

After long waits (decades in the case of Glenmont MetroCentre), two local redevelopment projects are now gathering steam.

Most noticeable is the start of construction on Phase 1.1 of Glenmont Metro Centre. This phase will construct 171 townhomes, Including 22 MPDUs (Modified Price Dwelling Units), on the property's easternmost third near the intersection of Layhill Road and Glenallen Avenue.

Winchester Homes is the builder.

Financial success with this project could demonstrate to other potential developers that there is real potential in the area around the Glenmont Metro Station, especially now that the Georgia Avenue and Randolph Road intersection modernization is underway. We can only hope that these milestones spur the long-overdue redevelopment of Glenmont Shopping Center.



Current Litigation

Henry v. Guirand (Case 2325, Maryland Court of Special Appeals; Petition Docket 614, Maryland Court of Appeals). A suit to, among other things, compel the BRPA to take actions against the "growing fence" at 14017 Breeze Hill Lane. In November 2014, the Maryland Court of Special Appeals ruled to dismiss the BPRA portion of the suit. In June 2015, the Maryland Court of Appeals denied the plaintiff's request that it review the case. In July, the plaintiffs petitioned the Court of Special Appeals to reconsider its November 2014 decision.



Klang v. BPRA (Case MU-254930, Office of the Attorney General of Maryland, Consumer Protection Division). A complaint that the BPRA Board of Trustees did not comply with the notice requirements of the Maryland Homeowners Association Act when it adopted the BPRA's FY16 annual budget (covering March 1, 2015 to February 29, 2016). The complaint has been referred to a mediator.

Update on Plaza Del Mercado Developments



Plaza Del Mercado

Federal Realty Investment Trust, the owner of Plaza Del Mercado, has signed leases with Aldi's and LA Fitness. LA Fitness will rebuild the Giant store site into a 2-story fitness center. Aldi's will rebuild the immediately adjacent retail stores for their grocery store. Aldi's stores are smaller than most grocery stores, similar in size to a Trader Joe's. You can see the store placements in the diagram below. Federal Realty also plans to refresh the facades for the entire shopping center and redo the parking lot to include new lighting and better lane definition. This will be similar in scope to the parking lot and façade refresh completed for Kohl's arrival in Aspen Hill. You can see elements of the parking lot redesign in the diagram.

This month, Federal Realty seeks approval to amend the approved Plaza Del Mercado site plan that included a major expansion of old the Giant store. Giant abandoned the idea of expanding at Plaza Del Mercado after obtaining the County's approval. The new plan requires less space than was approved for Giant. It also specifies an easement to allow a connection between Plaza Del Mercado and Layhill Center. This easement will require construction of the interconnection whenever Layhill Center is redeveloped.

There is no official schedule on when construction will start, but I expect we will begin to see activity early next Spring.

Getting your home insurance in order....Information for a smooth home sale:

Flood Coverage - Most policies cover water damage that occurs from above the ground, such as roof leakage, storm water pushed through window voids, and burst plumbing. Water that rises or seeps into a basement from the ground is considered a flood and is not insured. If you are concerned about ground water seepage & damage, you need a separate flood insurance policy.

Insurance companies share claim information with each other using the C.L.U.E. report, a standardized itemization of claims and, often, inquiries that a homeowner has made. Too many calls or claims can prevent the homebuyer from obtaining a new insurance policy or s/he may be quoted an outrageously high price. A savvy homeowner, in order to keep his policy intact and to have an acceptable C.L.U.E. report, will only make an inquiry or claim for major losses.

Deductibles - Since only large losses might be claimed, it may be economical to raise the deductible on your current policy to lower the annual premium.

Insurance When Selling - You should call your insurance company to let them know that you are putting your home on the market to be sure you are properly covered. After the sale, keep your policy in effect for a week or so until the buyer's deed has been recorded with the County.
