Dear Neighbor:

Happy New Year! The Bel Pre Recreational Association Board of Trustees wishes you a happy, safe, healthy, and successful 2024.

This mailing includes the bill for your 2024 BPRA annual household assessment, as well as updates from our Civic Association and the SBP Dolphins swim team. Your payment of \$400 is due March 1, 2024, and is considered late if not paid by that date. However, no additional charges are levied as long as payment is received or postmarked by March 31, 2024 (the "grace period.")

Please make every effort to pay your assessment on time. Prompt payments help you avoid delinquency fees and reduce the time our volunteers must spend collecting assessment payments.

Why must I pay this assessment?

Payment of the annual assessment is required by law. There is a covenant attached to your property deed, which is recorded in the Montgomery County Land Records. When you bought your home, or opted to join the BPRA, you accepted the legal responsibility to pay this annual assessment for as long as you own the home. Copies of the covenants are available on the Strathmore Bel Pre community website: StrathmoreBelPre.org/government-documents/, under the heading "Covenants – Bel Pre Recreational Association."

What am I paying for?

The annual assessment pays for operation, maintenance, and upkeep of our shared recreational facilities, and contributes to our Reserve Account in anticipation of future capital expenses. The Association's recreational complex is located at 13920 Bethpage Lane. We anticipate that the pool will be open from Saturday, May 25 through Labor Day, Monday, September 2. The tennis, pickleball, and basketball courts are accessible year-round. At less than \$35 per month, the annual assessment is a bargain compared to the cost of membership in a private swim and tennis club or the average HOA fee in Montgomery County.

How do I pay?

You may pay online via credit card (no transaction fees) or by paper check or money order. These are the only acceptable forms of payment. Board members are not authorized to accept hand-delivery of your payment.

Online: Visit StrathmoreBelPre.org/annual-assessment. This option should be enabled by February 1, 2024.

Paper Check: Write <u>one</u> check payable to Bel Pre Recreational Association. The total should include the mandatory BPRA Assessment and any optional payments. Include your BPRA street address on the check, and mail to: **Bel Pre Recreational Association, Inc., P.O. Box 6370, Silver Spring, MD 20916-6370.**

What happens if my payment is late?

If we have not received your assessment payment by March 31*, your account is assessed a one-time late fee of 10% (\$40.00); and, as required by a County Government Order, simple interest at 6% per year. Interest is accrued on the first day of each month retroactive to the March 1 due date (i.e., on April 1, you accrue \$2.00 in interest expense for the month of March; on May 1, you accrue another \$2.00 if payment was not received during April; etc.) *Payments mailed to BPRA must be postmarked by March 31, 2024 to be considered on time.

What happens if I do not pay?

The Association will make reasonable attempts to reach homeowners whose payments are past due. If you fail to respond to our attempts to contact you at your Strathmore Bel Pre address or the billing address of record, BPRA will refer your account to our attorney. BPRA's attorney is authorized to begin collection efforts; and, if necessary, to place a lien on your property deed. Homeowners whose accounts are referred for collection will be responsible for additional costs, including attorneys' fees, court filing fees, etc., which must be paid in addition to the total amount of unpaid annual assessments, interest, and late fees. BEL PRE RECREATIONAL ASSOCIATION (BPRA) 2024 Annual Assessment of \$400 is due March 1, 2024

*After March 31 additional charges including a 10% late fee (\$40.00), plus 6% interest per annum (\$2.00/month) and collection costs apply.

There are three ways to pay your Annual Assessment, update your homeowner records with BPRA, and confirm your pool check-in information for this summer.

1 - Online: Update information and pay with a credit card (NO FEES)

- This is the preferred method. Spending a few minutes updating your information and paying your assessment online saves our volunteers countless hours of data entry and check processing time.
- See the back of the assessment form for basic instructions and visit StrathmoreBelPre.org/annual-assessment for links and full instructions.
- Pay your BPRA annual assessment, join the SBPCA, and/or donate to the pet waste station, Summer Entertainment and Street Festivals or SBP Dolphins online, using a credit card.
- Update your eSoft Profile and Household Information.
- Confirm your pool check-in information when you pay your assessment.
- Indicate/update interest in volunteering for the community.
- If you make your payment and update your information online, you do not need to return the paper form.

2 - Online and via mail: Update information online and pay with a mailed paper check

- Pay your BPRA annual assessment, and/or join the SBPCA, make a pet waste station, Summer Entertainment and Street Festivals or SBP Dolphins donation with a paper check or money order.
- Update your eSoft Profile and Household Information online. See the back of the assessment form for basic instructions and visit StrathmoreBelPre.org/annual-assessment for links and full instructions.
- Confirm your pool check-in information online.
- Indicate/update interest in volunteering for the community online.
- Make check payable to Bel Pre Recreational Association.
- Include BPRA property address on check.
- Write one check for all payments (BPRA assessment, SBPCA membership, pet waste station donation, SBP Dolphins donation).
- Mail check and completed form to BPRA P.O. Box 6370, Silver Spring, MD 20916-6370.
- If you update your household information online, you do not need to return the paper form.

3 - Mail only: Update information and pay via mail

- Complete the enclosed BPRA Assessment Payment and Household Information Form. Make changes to owner names and mailing address as necessary.
- Make check payable to Bel Pre Recreational Association.
- Include BPRA property address on check.
- Write **one** check for all payments (BPRA Annual Assessment, SBPCA membership, pet waste station donation, Summer Entertainment and Street Festivals donation, SBP Dolphins donation).
- Mail check and completed form to BPRA P.O. Box 6370, Silver Spring, MD 20916-6370.

BPRA COLLECTIONS PROCEDURES

The full BPRA Collections Policy can be found at StrathmoreBelPre.org/government-documents.

The Association will make up to three written attempts to collect your payment (including all accrued interest, late fees, and our collection costs, as applicable). If we are unable to reach you or are unsuccessful in our effort to collect your payment, then the Board of Trustees will refer your account to our attorney for collection. At that point, you will become liable for additional costs, including attorneys' fees, costs associated with placing a lien on your property, and court costs if necessary.

For those experiencing documented, short-term financial hardship, BPRA has established an Assessment Assistance Committee to review and rule on relief applications. Relief requests must be filed **no later than March 31** using the required application, which is available on the community website at: strathmorebelpre.org/annual-assessment or may be requested from BPRA Treasurer Dave Pullen at treasurer4bpra@gmail.com or (301) 523-2448. As the Committee's authority is limited, homeowners requiring greater flexibility in making payment should consider paying the full Assessment by credit card, which allows the cardholder greater control over the payment timeline.

eSoft Menu Choices you will use to complete steps below:



- Steps 2, 3, 6 and 7: Hover over My Account for the drop down menu to: update My Profile, review My Memberships, update My Interests, or Add Family Member.
- Steps 4 and 5: <u>Click</u> Memberships on the top menu for the Swim Membership list.

1. Log in to your account.

- Your user name is probably NOT your email address. Use the link on the login page to retrieve your login or reset your password as necessary. If you cannot retrieve your information with those links, please visit StrathmoreBelPre.org/pool-access-esoft and fill out the eSoft Planner help form.
- 2. Review your PROFILE, ensure that your information (name, address, email address) is correct, and make any necessary updates. Make sure all resident household members are listed in My Profile. You can add additional household/family members in step 3. Do not add primary account holder as a Family Member.
 - Hover over My Account, click on My Profile.
- 3. ADD HOUSEHOLD/FAMILY MEMBERS, and upload photos as necessary.
 - These are your Household Members as defined by the BPRA Recreational Facilities Policy. Please note: just because a family member is listed in My Profile does not mean they are set up for check-in at the pool. The family member must be enrolled in the <u>2024 BPRA Annual Assessment due March 1, 2024</u> Swim Membership (Step 4) to be available for pool check in.
 - o **If you need to add a family member:** Hover over My Account, click Add Family Members. Fill in required information. Click "Add Family Member" at the bottom of the page. Repeat as necessary.
 - o **If you need to delete a family member:** visit StrathmoreBelPre.org/pool-access-esoft and fill out the eSoft Planner help form.
- **4. ENROLL** in the <u>2024 BPRA Annual Assessment due March 1, 2024</u> membership to **pay your assessment** and get set up for pool check in (you may pay online or by check.)
 - o Pay your BPRA Annual Assessment:
 - Click "Memberships."
 - Click "Sign Up" next to 2024 BPRA Annual Assessment due March 1, 2024.
 - Complete the steps for enrollment. Select pay by credit card or pay by check.
- **5. ENROLL** in the appropriate Swim Membership to join the SBPCA, or make a Pet Waste Station, SBP Dolphins or Summer Entertainment and Street Festivals donation.
 - Click "Memberships."
 - o Click "Sign Up" next to the membership you would like to enroll in.
 - Complete the steps for enrollment. Select pay by credit card or pay by check.
 - Repeat for each enrollment. There will be a separate credit card transaction for each enrollment.
- 6. Click on **MY MEMBERSHIPS**, and **VERIFY** that your membership is set up correctly. Family members must be listed in your <u>2024 BPRA Annual Assessment due March 1, 2024</u> membership to show up for pool check in. All valid memberships for 2024 have "Jan 1, 2024 Dec 31, 2024" as the membership dates. Prior year memberships are not valid for 2024.
- 7. Confirm or update **MY INTERESTS** to express interest in volunteering for the community. Please do this each year.
 - Hover over My Account, Click My Interests.
- 8. If you opted for check payment: After completing all membership enrollment selections, please write a single check to cover all enrollments. Make checks payable to BPRA, and note your property address on the check or on a separate piece of paper. Please mail your check to BPRA P.O. Box 6370, Silver Spring, MD 20916. Payments must be received or postmarked by March 31, 2024 to be considered on-time.
