Membership and ListServ



Gleanings From Meetings + More

County Executive Meeting - December 2, 2013

A number of representatives from the eastern side of the County met with County Executive Ike Leggett to discuss topics pertaining to their areas as well as countywide. Carol Barth (President of the Montgomery County Civic Federation and a White Oak resident) expressed concern about construction proceeding in the White Oak area before the revised Master Plan was adopted. A representative from Privacy World raised a water metering dilemma. Since Privacy World has a master metering system, condo owners pay a portion of their entire building's water usage rather payments based upon their own use, as would be indicated by individual unit meters. As a consequence and because some units housed six or more adults, many unit owners felt they are being overcharged.

Other topics broached with the County Executive were the development of the Rockville Science Center and the presumption that development in the area of Rockville Pike is heading into gridlock. A \$1.5 million study from the State Highway Administration concluded an additional lane would be needed. One of the participants suggested that all that was needed was to "paint an additional turn lane". Efforts are underway to address this concern through the County's delegation to the State legislature.

Mr. Leggett mentioned that the County would be leading on Bus Rapid Transit (BRT) installations, and that the County administration has decided not to accept the ceiling cracks in the Silver Spring Transit Center. The County expects that it will not have to pay for any additional work until the Transit Center is fixed to the County's satisfaction.

Public Schools: Taxpayers League Meeting - December 12, 2013

The Taxpayers League meeting featured Larry Bowers, the Chief Operating Officer for the Montgomery County Public Schools (MCPS). Mr. Bowers provided some facts and figures:

- 21,000 plus persons are employed by MCPS
- 2,700 new students are anticipated next year
- 2,000 new students is the average new student increase
- \$ 650 to \$700 million in capital improvements is anticipated
- 50 % of the school bus service supports special education
- Incentives for exceptional teachers to stay and/or go to high-need schools are in progress

Mr. Bowers indicated that expenditure information can be found on the MCPS website. He noted that the County Board of Education approves all contracts in excess of \$25,000. The Office of Legislative Oversight of the County Council conducts reviews as does the State Legislative Office every five (5) years. According to Mr. Bowers, MCPS are subject to "... extensive review and auditing ..." that emphasizes "compliance" not "efficiency" or "effectiveness".

67 elementary schools are in a Red Zone, as focus schools where students in Kindergarten through Grades 1 and 2 receive extra funding and lower pupil/teacher ratios. Parent Teacher Associations (PTAs) that readily raise \$50K or more are in a Green Zone, as "non-focus schools". Red Zone PTAs lack that fund raising ability.

Cost per student per grade for 2015 :

Kindergarten/elementary: \$ 14,454

Secondary: \$ 13,932

Average for all grades: \$14,181

FY2105, proposed Budget is \$ 2,281,809,121. FY 2014, the budget is \$ 2,225,421,052.

Covenants and the County Code

Did you know that many of our covenants are similar to regulations that are enforceable by the county? The Montgomery County Code Enforcement Section is a division of the Department of Housing and Community Affairs. Its mission is "to maintain and preserve the quality of life in Montgomery County in general, and that of our neighborhoods and housing stock in particular." The Code Enforcement Section administers housing and building maintenance standards, solid waste, and weeds.

According to the Montgomery County building code, owners and occupants both have several responsibilities. All exterior components of the house must be kept in good repair, and the dwelling and premises must be maintained so that they are clean and sanitary. Occupants must also maintain grass below 12 inches in the yards of single family dwellings. All solid waste must be disposed of in proper containers, and it is unlawful to store unused vehicles for more than 30 days on private property.



Current Litigation

As we go to press, the Bel Pre Recreational Association is the defendant in two law suits:

Henry v. Guirand (Case 2325, Maryland Court of Special Appeals). A suit among other things to compel the BPRA to take actions against the "growing fence" at 14017 Breeze Hill Lane. On January 10, 2014, the Court ruled in favor of the BPRA (i.e., dismissed the BPRA portion of the suit). On February 7, the plaintiffs asked the court to reconsider its decision.

Guirand v. Bel Pre Recreational Association, Inc. (Case 383580, Montgomery County Circuit Court). A suit to enjoin the BPRA from taking actions against the fence at 3200 Bustleton Lane. The BPRA filed a motion to dismiss on February 10, 2014.

Open Government and Transparency Montgomery County Civic Federation (MCCF) meeting – January 13, 2014

Presenters were Robert Cobb from the County Ethics Commission, Alisha Green of the Sunlight Foundation and Jennifer Bevan-Dangel, of Common Cause. 40% of people already seek data on-line about County and State Government. One source for information relating to all 50 states is http://openstates.org.

Mr. Cobb and two staff members administer the County Ethics Law, which covers some 87 County boards and commissions, as well as the County Council and County employees. The Ethics Commission reviews individual actions such as lobbying, outside employment, conflicts of interest, prohibited holdings, misuse of office, gift rules, and use of government resources for private purposes. Lobbyists spending \$500 or more on County legislative action(s) must register with the Ethics Commission. Non-profit representatives spending \$1,000 or more must register, and pay a fee to the County of \$125. The Ethics Commission also deals outside employment requests and has a close relationship with the County's Inspector General's Office.

Ms. Bevan-Dangel, of Common Cause, noted that the threshold for lobbyist reporting at the State level is \$2,500. One of her objectives at the State level is to improve access to lobbyists' and representatives' disclosure information. She expressed concern about the brief waiting period for a legislator to resign and become a lobbyist – one legislative session. She also expressed reservations about the level of accessibility available to the public, due to numerous exemptions and the fees. In some instances, a requestor is restricted to reading certain supposedly public information under observation. Much information in Annapolis can be obscure and difficult to access.

County Council President Rice: Taxpayers League meeting - January 16, 2014

The meeting featured Craig Rice, newly elected President of the County Council. President Rice observed that he represents Gaithersburg and the upper County, including Damascus, but that he had grown up in the Layhill area. He addressed his remarks to a variety of issues, in response to questions submitted in advance by the Taxpayers League.

Education Issues

President Rice noted that approximately 50% of the County budget is devoted to education. With respect to the Capital Budget, he described the significant need for more space at Poolesville High School. Students are eating in shifts in the halls and the cafeteria is also being used for gym classes. In response to a suggestion that portable classrooms be used as an alternative to school construction, President Rice said they might be used as a "stop gap measure" but that he strongly favored buildings. In response to a query about the level of taxation in the County, he expressed concern but defended the merit of current taxes in paying for the County needs.

The discussion about the Maintenance of Effort (MOE) imposition by the State on each of the counties was fairly limited. The Maintenance of Effort state law requires public schools to continue their funding levels from year to year, and is used as standard by the State and some Federal agencies. Unfortunately, Montgomery County significantly exceeded its State-defined Maintenance of Effort requirement during years in which tax receipts were strong. The County has found itself struggling to meet this higher level of commitment with the lower levels of tax revenues. It was mentioned that the teachers' union and the State are strong MOE supporters.

He expressed strong support for more School Resource Officers while noting that some citizens as well as some County Council members did not believe that Resource Officers were warranted

New Initiatives by President Rice

President Rice informed the Taxpayers League that he was appearing on Channel 9 to spell out his initiatives and priorities and was utilizing radio as well. One specific initiative for him is to increase participation in Government on the part of lower earning individuals and families.

GETTING CONTROL OF YOUR PAPER FLOW...A FEW TIPS!

Is your desk or counter top attracting papers? Sometimes the paper piles can seem uncontrollable. Here are a few tips from Elizabeth Mayhew of Real Simple magazine:

Establish a system for organizing mail: 1) Designate an in-box for the mail - big enough to hold a week's worth of papers, but no more, so you can't let things pile up. 2) Deal with mail when you get it. Throw away junk mail before taking your coat off. Put catalogs and magazines in a separate basket to go through later and put mail in you in-box. 3) Keep a large wastebasket near your in-box. Getting rid of bulk makes the paper you have to deal with less intimidating. 4) Pick a regular time to sort through your in-box. Whether it's one hour a week, or a couple minutes a day, pick a schedule that fits your lifestyle and stick to it.

Types of mail: 1) Invitations - decide quickly if you will attend, mark invitation once you have replied, put the invitation in a visible place, put the date in your calendar right away and toss the invitation after the event. 2) Bills—use a portable filing system. Keep everything you need together: checkbook, stamps, and a pen in your organizer. Choose a labeling system that works for you. Pay the bills daily or use a weekly system. Once bills are paid, move them to a file cabinet or stor-

Meeting with the County Executive Ike Leggett – January 27, 2014

The County Executive, Ike Leggett, held a public meeting at the Queensguard Recreation Center regarding the proposed Montgomery County budget for fiscal year 2015. After a series of countywide public hearings, Mr. Leggett will submit his proposed 2015 budget to the County Council on March 15, 2014.

At the Budget Forum, individual citizens as well as those representing particular organizations or special interest groups engaged in a colloquy with Mr. Leggett about their issues and concerns. Most of the speakers thanked Mr. Leggett for his past support relating to their area of interest and urged him to increase the County's commitment as much as possible. Areas of particular concern included more funding for mental health-related needs, more assistance for low income housing, libraries and developmental disabilities. One community member referred to the area as a supermarket desert because of the difficulty in getting a replacement for Giant at Plaza del Mercado.
