### **November General Membership Meeting**

On November 19, 2019, the Bel Pre Recreational Association (BPRA) held it's Annual General Membership Meeting, which included the election of 3 trustees and presentation of the Long Term Planning Committee's assessment proposal. Thank you to everyone who attended or sent in a proxy, and to our election judges.

Congratulations to Mark Foraker, David Pullen, and Chris Swan for their election to the BPRA Board. Outgoing Board members Elliot Chabot, Chris Jennision, and Megan Virga did not run for re-election. Their many contributions to the board will be missed.







BONNIE CULLISON, senior District 19 State Delegate, and our neighbor, discussed current state legislation regarding homeowner and condominium associations. The legislation aims to strengthen their financial stability through long term planning and reserve funds. Bonnie also mentioned Wheaton Woods Swimming Pool's financial troubles, that resulted from a broken main pipe and no funds to fix it.

### Long Term Planning Committee Research and Dues Assessment Proposal

The Long Term Planning Committee presented their report and recommendations, based upon survey results from the Summer BPRA Community Survey, research and work of the Committee.

Committee member CHRIS WRIGHT presented the results of the BPRA Community Survey, which was conducted from late May to mid-July 2019. CHRIS discussed community opinions on BPRA facilities usage, community interest in facility improvements and off-season use, pedestrian and bicyclist safety, crime, the BPRA Board, communication and other community issues. Further details of the Community Survey results can be found in the October 2019 edition of *The Bugle*.

Following a question and answer session about the Community Survey Results and related Long Term Planning Committee initiatives, KAREN explained the research and methods used by the Committee to develop the assessment proposal – including the state of BRPA facilities, development of the Five Year Plan for BPRA Facilities, research and analysis of assessment options, review of several assessment scenarios, the need to tie the annual BPRA assessment to inflation and next steps for the Long Term Planning Committee. **TETE NARH-MENSAH** worked with the American Red Cross to organize and host a blood drive at the Church of Christ at Manor Woods. During the drive there were 30 eligible participants who donated blood, meeting the goal of 25 pints. The other scouts in our troop also taught people, who were waiting to donate, how to make paracord bracelets for the armed forces.

**BEN WEINER** also did his project at the Church of Christ at Manor Woods on Bauer Drive. The church decided it would like a fire pit on the church grounds as a place for activities and social events. Ben did the fundraising from the congregation, worked with the site manager to develop a plan, and then directed his fellow scouts and adult volunteers to remove sod, move 5 tons of rock dust, compact it to prepare the site and then build the fire pit. 

### A Bird For All Seasons

When you walk outside and hear a car alarm coming from the top of a tree, it's likely that you're in the territory of a Northern Mockingbird. These professional mimics don't imitate only bird songs; any noise they

hear is grist for their gray-feathered mill. The species is aptly named *Mimuspolyglottos*.

I'm happy to say we usually have a mockingbird in charge of our front yard all year round. Mockers are mostly quiet in winter, so our current fellow probably won't start mimicking titmice and sparrows until April, but it's a pleasure to watch him in all seasons. Besides lighting up the musical scene, our avian proprietor is clearly a stubborn, opinionated individual who seldom comes off the loser in a fight. Okay, this is perhaps a bit anthropomorphic, but anyone who has been dive-bombed by a territorial mockingbird will know what I mean.



Mockingbirds stake out breeding territories in the

spring and feeding territories in the fall. Mockers don't care about seed feeders, but may come to suet. Our area has good winter supplies of bugs and berries: dogwood, holly, and juniper berries, plus the vestiges of tiny fruits on decorative fruit trees, vines, and shrubs. Our big front-yard juniper, trimmed to a Christmas-tree shape, is a multi-purpose structure, offering dense cover and a terrific watchtower. Our mockingbird-in-residence often perches at the top, keeping a watchful eye on his property.

Here's an example of how vigorously a mockingbird will defend a winter territory. We used to have two Bradford pear trees in the front yard (gone now, snapped off in storms) that once afforded me a view of the most decisive mockingbird action imaginable. That late winter day, a large flock of starlings had filled our leafless pear trees; the trees looked as if they'd leafed out in black. Our resident mocker took offense at this violation of his premises. Moving at ramming speed, he dashed at one starling after another, driving them out one-by-one. Branches bounced and shook as the gray dynamo moved systematically to evict




invaders from first one tree, then the other. Then he repeated his cycle, cleaning out the few stragglers. At the end, both trees, once full of noisy jostling life, were empty. The mockingbird took a victory lap and then flew off to patrol his boundaries.

Winter or summer, we don't often see mockingbirds in the back yard, except for occasional visits to the suet feeder or to drink from the birdbath. But that might change this year. We're upping our game in the back yard this spring, adding new native plants (carefully chosen with our deer population in mind). We're also incorporating a County-approved conservation landscape that will help protect the Chesapeake Bay. Stay tuned!

### Three General Membership Meetings Held in January 2020

In January 2020, the BPRA held a series of meetings to discuss and vote on the Long Term Planning Committee's assessment proposal: January 9<sup>th</sup>, January 16<sup>th</sup>, and January 23<sup>rd</sup>, 2020. At each meeting, members were given a chance to ask questions and discuss the proposal.

The first planned opportunity to vote on the assessment proposal was Thursday, January 9. A quorum was not reached at this meeting, therefore, voting on the proposal did not take place. The meeting was adjourned. The membership reconvened on Thursday, January 16, 2020. Again, a quorum was not reached and voting did not take place. On Thursday, January 23, 2020, the BPRA membership reconvened for the third and final meeting to vote on the assessment proposal. A quorum was reached and voting took place. The assessment proposal was adopted with 88% of votes In Favor of the proposal.



Based on the adopted assessment proposal, and vote by the BPRA Board to assess the newly adopted maximum amount, the assessment due March 1, 2020, is \$300. Additional information about payment of the Annual Assessment can be found in this edition of *The Bugle*, on page 17.

### Notes from the Glenmont Exchange

### **Kennedy High School Expansion**

MCPS is planning a 3-story addition to Kennedy HS which will include eight standard classrooms, one drama classroom, a special education suite, two science labs, a technology suite, a multipurpose lab, a medical careers academy, a school store, and offices. The 17,000SF foot facility will allow for an additional 429 students for an enrollment capacity of up to 2,221 students. The addition will be built on the Middlevale Lane side of Kennedy.



Contingent on funding through the Montgomery County Department of Health and Human Services, a School-Based Wellness Center will be included as an alternate for the project, which would serve students and their families. The project will also replace the existing natural grass stadium field with artificial turf. Parking will also be expanded with a new surface parking lot in on the school's north side that will add about 108 spaces.

### **Wheaton Regional Park Master Plan Update**

Montgomery Parks is updating the 1987 Wheaton Regional Park Master Plan and is seeking input from park users, especially from neighborhoods near the park. The planning team presented to the Glenmont Exchange at our November meeting.

They noted that the park functions more like a collection of neighborhood parks than an integrated regional park. In the plan, they want to improve the connections between segments and improve walkable access. They are considering new facilities and converting some fields in the athletic area from diamond fields (baseball) to rectangular fields (soccer). Additional amenities to serve our



diverse communities will be considered. Under any plan, 2/3rds of the park will remain natural area.

They are reaching out for community input through the Spring and plan several public events and town halls. Send your input to project manager CHUCK KINES at Charles.Kines@montgomeryparks.org. They are due to present a report to the Planning Board in the Fall. They will have a booth at Taste of Wheaton on June 7th.

### **Glenmont Shopper's Sold to Lidl**

The Shopper's Food Warehouse location in the Glenmont Shopping Center has been sold to Lidl, a





German-based grocer similar in concept to Aldi. The Shoppers store should be completely closed by March. Lidl purchased six sites from Shoppers. A Lidl spokesman said in December that Lidl "will be making significant investments in the redevelopment of the sites and will have more to share regarding the grand opening timeline at the end of next year."

The shift from Shoppers to Lidl could expand the need for a full-service grocer in Glenmont, possibly helping Glenmont Metrocentre with their search to find a full-service grocer tenant for their planned development at the corner of Georgia and Glenallan across from the Glenmont Metro Station.

➢ By now, you should have received your annual BPRA assessment notice. The annual assessment of \$300 is due March 1, 2020. Please pay your assessment on time. Most of you do, and we thank you. If we do not receive your



payment by **March 31**, your account will be subject to a \$30 late fee, interest of 6% per annum and all collection fees. In addition, access to the pool and related facilities is not permitted for households with delinquent accounts. ### **Civic Association Changes Its Membership Mailing Date**

For decades, the Strathmore Bel Pre Civic Association (SBPCA) and the Bel Pre Recreational Association (BPRA) have sent separate dues mailings to our community. The Civic Association mailing historically goes out in August and the Rec Association mailing goes out in February. Each mailing costs each organization about \$500.



As announced at the Annual Meeting, our 2 organizations are planning a joint mailing in 2020, thereby dividing up and cutting the mailing costs for each organization. Since the Covenants control the Rec Association mailing schedule, the Civic Association is changing its membership mailing schedule to align with the Rec Association schedule.

As a result, when you receive your annual Recreational Association dues mailing this year, the response form will include a new option to add your \$18 Civic Association membership dues to your Rec payment. The mailing will also include membership letters from the Civic and Recreational Associations.

We hope that this change, by combining two payments into one, offers our members a small but welcome reduction in your paperwork burdens. We also hope that this change helps more Recreational Association members join the Civic Association. Historically, only about 30% of BPRA members are also SBPCA members, so the Civic Association has much room to grow!

Households that receive *The Bugle* but are not BPRA members will receive a separate mailing directly from the Civic Association. Financially, this change means that Civic will receive its 2020 dues earlier, in March/April instead of September/October.

Dues, due? What happens when you do not pay them??

### New to the Neighborhood?

If you are a new member of the Strathmore Bel Pre Recreational Association, and did not receive your annual dues notice in the mail, notify the BPRA Treasurer in March! Late fees will apply as of **April 1**st.

#### The Dues

The Bel Pre Recreational Association (BPRA) Fiscal Year runs from March 1<sup>st</sup> to the last day of February. Annual dues notices with the assessment amount are sent to Recreational Association property/home owner members in February. Payment is then due by March 1<sup>st</sup>. For 2020, the assessment is \$300.

### Who Pays These Dues and Why?

Property owners in the Bel Pre Recreational Association are legally required to pay the assessment every year, as long as they own a property connected to the BPRA! Paying your dues entitles your entire household to use the pool, tennis courts, etc. You are also entitled to vote at BPRA General Membership meetings. Even if you don't use the pool, the playground, the tennis courts, or attend General Membership meetings, paying your dues maintains the recreational facilities, which preserves the value of your home!

### Payment by April 1st 🙂

Many thanks to our BPRA members (the vast majority) who pay on time!

### No payment by April 1st? Delinquent!

If BPRA has not received your payment by March 31, you are delinquent.

### **Letters Go Out**

Each delinquent homeowner will receive *up to* three letters over the course of the next few months seeking payment.

### Costs to Eliminate the Delinquency Go Up

Every month an account remains delinquent, the amount owed to bring it current increases, as follows:

- April 1<sup>st</sup>: Homeowner owes the base payment (\$300) plus a late fee equal to 10% of the assessment amount (\$30); plus simple interest at 6% per year (\$1.50/month); plus our collection costs (\$10.00) for a total due of \$341.50
- May 1<sup>st</sup> to July 31<sup>st</sup>: Every following month the assessment remains unpaid, add \$1.50 in interest, plus collection costs of an additional \$10.00 for each additional reminder letter.

### No Payment Received by August? Legal Action and Attorney Fees

The BRPA Board authorizes referral of the matter to legal counsel for collection. Once legal counsel is engaged, BPRA will communicate with the homeowner only through the association's attorney.

The dues collection and settlement includes: 1) the homeowner's payment of all outstanding fees owed *plus* 2) legal fees/expenses incurred to that point, which may easily double or triple the amount owed. If no settlement is negotiated, the Board will authorize the BPRA's attorney to proceed to court for judgment. BPRA will seek a court order compelling the homeowner to pay all owed and accumulated fees and expenses associated with the claim. A lien also will be executed against the homeowner's property.



### The Exception

Homeowners may present extenuating circumstances and receive a payment plan. Such plans can be granted by the BRPA Board, in its sole discretion. The assessment and fees, etc. still must be paid.


### In Memoriam: Maury Potosky

MAURICE "MAURY" POTOSKY, a long-time leader in the Strathmore Bel Pre community, passed away on November 30, 2019 at the age of 90. He and his wife, Charlotte, were original owners here beginning in 1972.

When Levitt & Sons turned the pool property over to the community in 1972, MAURY was a leader in the effort to make sure the first BPRA elections were open and fair. MAURY also led the effort in the 1970s to block an attempt to double-charge members of our community with Washington Suburban Sanitary Commission fees. The community wound out settling out of court, but got back almost all of the extra charges Levitt had intended to pass on to the community.



MAURY served well over 20 years as a member of the Board of Directors of the Strathmore Bel Pre Civic Association. He was re-elected to the Board in 2017 (at age 88) for another 3-year term. Throughout the years, MAURY was always a source of practical, helpful knowledge and advice, with a solid understanding of our community's history, foundations, traditions, and, of course, the BPRA covenants.

MAURY was a dutiful member and leader of the SBP community. He rarely missed a Civic Association meeting and I don't think he ever missed an Annual BPRA Meeting, always doing his part to help our community, even if only to help meet the quorum. He was our last Annual meeting, on November 21<sup>st</sup>, just a week or so before he passed.

MAURY and CHARLOTTE were also briefly profiled, along with others, in the April 29, 2011, *Washington Post* article on Strathmore Bel Pre.

MAURY wrote the definitive article on BPRA covenants published in the June and November 2012 issues of *The Bugle*. MAURY founded and led the Bel Pre Investment Club. for over 18 years. When that club closed down, he joined a large club of independent investors, serving as its local treasurer. Charlotte and Maury also led our community's 50 Plus Club for over 18 years.

MAURY was born in Bronx, New York, and attended the Bronx High School of Science. He went to New York University where he received a degree in Systems Engineering. He worked for the Navy for many years on classified projects dealing with underwater security systems. He left the Navy, worked at Philco, and then returned to the Navy, where he completed his working life. In addition to his wife, Charlotte, Maury is survived by 4 children and 8 grandchildren.

MAURY was also active in the autism community, supporting his grandsons BEN and SAM. For many years, MAURY and CHARLOTTE have raised funds for the Autism Speaks Annual Walk. In 2019, MAURY and CHARLOTTE were the number two fundraising team in the DC region. Over the years, MAURY and CHARLOTTE raised more than \$250,000 for autism research!

Also, she and Maury provided Sabbath services for those who live in care residences and cannot attend services away from their residence. Charlotte continues to carry on their long-time traditions. Maury was also active in the national organization of the Conservative branch of Judaism, serving as a vice-president, and organizing programs for seniors.

We must mention in addition to Maury's many activities and accomplishments, that he was a "Tzaddik". In Hebrew, "Tzaddik" means a righteous person. Everyone who knew Maury over a long or short time, or perhaps just from one meeting, realized that Maury was a genuinely good person, who helped all in need, possessed great wisdom and much knowledge, and served his community, his religion, and his fellow man to the utmost. He will be greatly missed. May his memory be for a blessing.

### **Aspen Hill Library News**

### **Will Jawando Community Forum**

County Councilmember WILL JAWANDO came to the Aspen Hill Library on January 11. Councilmember JAWANDO is the County Council's lead on library issues. He has announced that he intends to hold a "community conversation" at each of the public libraries in Montgomery County. Several senior staffers from the County Department of Public Libraries also attended the Aspen Hill meeting.



### Numerous Aspen Hill Library concerns were raised at the meeting, including: The Missing Curb Cut

The Curb Cut in front of the main entrance to the building was removed during the 2017 mini-renovation ("refresh") of the Library. The only curb cuts now are in the handicapped parking area and at the sidewalk next to Aspen Hill Road. Assistant Director for Facilities and ADA ANGELISA HAWES responded that the decision was made by the County's Department of General Services, not by the Library Department.

### **Change and Loss of Library Staff**

Since August, the Aspen Hill Library lost its Head librarian, its Head Children's Librarian, its Teen Services Librarian, and its Head Adult Services Librarian, and some Circulation staff. Two of those positions were still vacant as of the January 11 meeting.

### Flooding in the Library Basement

Since the Aspen Hill Library reopened in 2017, there have been numerous floods in the downstairs of the building – after just about every major rain storm. Assistant Director HAWES reported that the Library Department and the Department of General Services are trying to figure out why there is still flooding and an outside expert has been brought in.
