

Neighborhood Parking

The Civic Association hosted a virtual Zoom meeting on April 27th to discuss the parking issues we have in our neighborhood, especially along Hewitt Avenue and Blue Spruce Lane and on Beaverwood Drive. We welcomed over 25 neighbors on this Zoom call and we hosted a great discussion around these parking issues discussing possible solutions.



We submitted an application to the Montgomery County Department of Transportation for their residential parking permit program for just the Blue Spruce Lane/Hewitt Avenue section of our neighborhood as a test case and we just heard back from them this week to let us know we do not qualify for this program at this time. This program was developed to assist neighborhoods who border large Metro stations and have parking issues with daytime users. Our problem is with overnight parking, but MCDOT surveyed this section of our

neighborhood in both the daytime and evening and did not find enough of a problem to qualify for this permit program. They have asked us to resubmit if the volume of vehicles increases. Evidently, we need over 50% of the parked cars on the street to be from outside of our neighborhood to qualify. We continue to work on this issue and have promised to host another virtual meeting on this topic later this summer.

Enjoy the Pool This Summer

We organized another meeting with the Emergency Planning Committee to discuss the COVID pandemic and suggest ways the BPRA should open our pool this summer. We had a lively discussion around possible pool rules. With the CDC and our County rolling out new guidance on a daily basis, this is no easy task! The good news is our pool can open for the whole summer season this year. I am most thankful to all of the volunteers who assisted with this important work.

I hope everyone will consider using the pool and pool grounds this summer, enjoy the snack bar when it opens and attend the movie nights. Have you ever considered Water Aerobics with COOKIE STAGNITTO?

She will instruct us again this summer, so come and join us for water aerobics. I will be there for sure!

Pool Opening Summer 2021

As of this writing, we are one week away from

opening the pool and although some COVID protocols remain in place, we are very happy to announce that most of the limits and restrictions from last summer are no longer necessary. The pool will be fully open, with no "pods" or reservations, and no time limits for swimmers, as long as we remain within our occupancy limits.



A few things to keep in mind:

- 1. All members must complete, sign, and return their COVID waivers on the day of their first pool visit.
- 2. All members must CHECK IN when arriving and CHECK OUT WHEN DEPARTING. This is critical, as County guidelines still require that we maintain a count of people within the gates.
- 3. All members should review the full rules carefully with your household. Rules are posted at the pool and at StrathmoreBelPre.org.

The public health situation is evolving rapidly, and the BPRA Board will continue to evaluate new guidance from local authorities. As local and state guidelines change, we will update our rules and protocols regarding occupancy, social distancing, face coverings, etc.

With the new online system in place, and frequent changes in local regulations, we do anticipate some confusion and perhaps a hiccup here or there. We ask for your patience as we work to ensure that our members enjoy a fun, relaxing, and safe summer at the pool.

Thank you to JOE MOELLER, TED BECHTOL and the Georgetown Aquatics staff for their hard work in getting the pool ready to open. JOE and TED spent many hours at the pool working on a variety of projects and coordinating with contractors.

Thank you to CARMEN WONG for putting together and mailing over 200 sets of season passes to our members. Thank you to the members of the Emergency Response and Planning Committee chaired by NANCY BECHTOL, and the BPRA Board for staying on top of COVID rules and restrictions and working through many iterations of the Summer 2021 Rules and Operating Procedures.



Lap Lanes and Water Aerobics

New this summer! By popular demand, we will be offering up to 6 lap lanes from 6:30 pm until close on Tuesday and Friday nights. Lanes may be used for lap swimming, water walking or other appropriate exercise. Multiple swimmers from a single household, or up to 2 swimmers from different households, may use each lane.

Reserve a lap lane by logging into your eSoft Planner account or by calling the pool. Lanes can be reserved up to two days in advance. See StrathmoreBelPre.org or the bulletin board at the pool for more information.

On Monday evenings starting June 14, our very own MARIA "COOKIE" STAGNITTO will be teaching water aerobics. Cookie plans on teaching both shallow water and deep water classes. Please see the bulletin board at the pool for more information, including class times, cost and sign-up procedures.

20906 and COVID-19: By the Numbers



On April 13, 2020, the Montgomery County Department of Health and Human Services began publishing the daily cumulative tally of COVID-19 cases by zip code (from the Maryland Health Department). When the first 7-day average number of new cases was published on April 20, 2020, we were running 14.00 new cases per day in Strathmore Bel Pre's zip code (20906). We reached 32.71 new cases per day on May 25 and then saw a gradual decline through June 28, when we got down to just 6.00 new cases per day. Numbers started to drift up after that point, but then fell as low as 4.71 new cases per day (per 7-day average) by August 30, 2020.

With the end of summer, the numbers started to drift up again. By January 12, 2021, we were experiencing a 7-day average of 51.57 new COVID-19 cases per day in our zip code. On May 13 of this year, our zip code was recording a low of just 1.29 cases per day. Since then (as we go to press) the average has bounced between 1.86 and 3.00 new cases per day.

The next issue of *The Bugle* is scheduled to be published in October 2021. It is my hope that I I can report that we've gotten the number of new cases down to zero and the pandemic is over.

Please be careful, though. Last summer it seemed like were on the verge of being over



this, but it didn't happen. Please keep yourself and your friends and neighbors safe.

Tennis Courts Renewal and Pickleball Courts Creation

Tennis Courts Closure: 45 days

BPRA tennis courts will be locked with new locks and unavailable, effective **May 16**, and continuing for approximately 45 days, weather-

dependent. Players should seek alternative venues for play during this time. The closure is to enable repair/restoration of the courts to safe play condition. The Bel Pre Recreational Association (BPRA) Board approved a contract for this work earlier this year, after many years of effort to get the courts refurbished.

Pickleball Courts Creation

The first step in the renewal plan begins with the creation of additional footers to allow us to convert one tennis court into two permanent pickleball courts. Pickleball is one of the fastest growing racquet sports in the country. With two courts on our BPRA community property, this is a good way to allow our members to join the "wave!" While pickleball is especially attractive to seniors, the sport attracts players of all ages. You can even find professional pickleball matches on television these days! The remaining 3 courts will continue as standard tennis courts.

Tennis Courts Restoration

The contract work to be performed includes professional power-washing, followed by repair of the (many) cracks and especially those that have made two of the courts unsafe for play. Finally, the entire surface will be repainted in US Open blue colors and new white lines. The entire project is estimated to take about a month, provided the weather cooperates. If the nighttime temperature drops below 64 degrees, or if we get extensive rain, the timeline for completion will be extended.

The end product should be full restoration of the courts to excellent playing condition, plus the advantages of new playing opportunities for pickleball players as well as those who might want to try the sport.

Thanks to all for your patience during the repair work! We will advise you when work is completed and the "old" locks are returned, for which many homeowners already possess keys.

Tree Removal and Other Grounds Work

Over the past 5 years or more, the Board has been surveying the grounds with a certified arborist on a regular basis. Each year we prioritize needs and then remove dead, declining, and hazardous trees across the property. In addition, pruning work is done to improve health and safety of remaining trees.

Over the past several years, many large white pines along the perimeter of the property have been removed. While those pine trees provided excellent screening for the first 20-25 years of their life, they began to gradually lose their lower branches, losing their screening value, and growing too large for their location, requiring removal. The remaining trees along the perimeter of the property are assessed on a yearly basis.

This spring, we performed two rounds of tree work. In preparation for the tennis court repair project, the large white pines next to the courts were removed. Those trees were deemed problematic for a number of reasons, including upheaval of the adjacent sidewalk, threat of damage to neighboring properties and numerous limbs overhanging the tennis courts. Several other trees on the property, Including some perimeter pine trees were removed or pruned.

With an eye towards maintaining a pleasing and well maintained landscape, our tree and grounds work is not just limited to removal and pruning. A number of new trees and other plantings have been added to the grounds over the last few years. The Board will continue to establish new plantings in a number of locations in the near future, including between the tennis courts and sidewalk. Turf maintenance is done on a yearly basis and in an effort to offset the rainwater runoff from the large quantity of hardscape on the property, research and planning for a rain garden or gardens is underway.

TED BECHTOL, our Grounds and Landscaping Coordinator, coordinates all of these efforts and spends a significant amount of time doing work on the pool property. Thanks, TED.





Our Conservation Landscapes: an Update

During this spring of hope, flowers as bright as the sun livened the swale along the edges of our back yard. Golden ragwort has spread and flourished as planned in the new gardens. Shrubs all came through the winter, new growth has started, and everything is working on behalf of the Chesapeake Bay.

It's been a year since our two conservation landscapes were installed. Our landscaper, Backyard

Bounty, worked with Montgomery County's Department of Environmental Protection to design the two areas where water flow piped from the roof of our house would be slowed by small rocky check dams and intense plantings. Non-native wineberry and other invasives were removed. They were replaced by shrubs and perennials that would prosper in shady conditions, soak up water, and serve to mask our neighbor's fence.

As I write in mid-May, the ragwort's golden cheer is subsiding into tufty white seed-heads, and the Arkansas bluestar is blooming. Wood ferns flare amid the sedges. Joe Pye weed and mallows are up, promising luscious red beauty. Shrubs like winterberry, bayberry, and blackhaw viburnums are thriving.





I'm getting my anti-deer spray ready. I've observed that while deer don't do a lot of damage to most mature woody plants, they do enjoy various snacks. Those turned out to include the sweet furled buds of the mallows and the tender new growth on the baby shrubs. The bayberry plants weren't bothered much, but the winterberries and viburnums were chewed last summer—and they're small enough to still be at risk. Aromatic sumac, planted near the steps leading down into our tiny patch of woods, unexpectedly took the biggest hit from the deer.

Even when one plans for plants that resist deer pressure, and even when tasty things are surrounded by non-tempting sedges and ornamental grasses, vigilance and stinky stuff are necessary. This year I'll concentrate attention (and repellents) on the plants that need the most help to get to maturity. I'll spray what I have to, of course. But the plants, the deer, and I will all adapt. Example: though deer still prune the low branches of our big viburnum and silky dogwood, installed many years ago, I've learned to enjoy the exuberant vase-shape that results.



Watching nature, even when struggling with some of its components (I'm looking at you, scale insects and deer) is one of the nicest ways I know to feel at home.

We need you, this place isn't going to run itself!

The Bel Pre Recreational Association (BPRA) Board is the governing body for our community neighborhood association. The Board is comprised of nine elected volunteer Board members who each serve three-year terms. Each year, three seats are up for election, so if you missed the opportunity to run one year, a second chance is right around the corner. This is an active Board, one that



is charged with running and maintaining our communal grounds (pool, tennis courts, etc.) and ensuring we comply with County and State regulations for homeowners associations.



Strathmore Bel Pre History Project

In the May issue of *The Bugle*, I put out a call for help in locating copies of old issues of *The Bugle*, and the minutes of the Bel Pre Recreational Association (BPRA) and the Strathmore Bel Pre Civic Association (SBPCA). Many thanks to JAN WISOR and BRENDA HENRY for coming forward! BRENDA was able to fill in many important gaps in the BPRA records from 1999 to the present. JAN was able to provide a treasure trove of even older documents – including copies of the September 19, 1966, minutes of the Board of Directors of the Bel-Pre Community Association. September 19 was the first meeting of what became the BPRA Board – after Levitt & Sons (the original developer of Strathmore Bel Pre) incorporated the organization on September 2, 1966. The following year (1967), the BPCA became the BPRA.

Thrive Montgomery 2050 – Planning Board's Proposal to Change the County's Approach to Zoning

The Montgomery County Planning Board started a review of the County's General Plan for private and public land use and zoning in 2018. In April 2021, the Board, chaired by CASEY ANDERSON, released a 160-page proposed plan (*Thrive Montgomery 2050*). The County Council has scheduled public hearings on the plan for June 2021.





Current General Plan

In 1964, the Montgomery County Council adopted *On Wedges and Corridors: A General Plan for the Maryland-Washington Regional District.* The 1964 General Plan set out the standards for both private and public land use and development in Montgomery County. The goals and objectives of the General Plan were updated in 1969 and 1993. The details implementing the General Plan have been defined and expanded by a series of master plans and sector plans adopted by the County Council.

Master Plans for Our Community

Master plans that focus particularly on our community are the 1989 Kensington-Wheaton Master Plan (which includes the southern half of Strathmore Bel Pre) and the 1994 Aspen Hill Master Plan (which includes the northern half of Strathmore Bel Pre). The Glenmont Sector Plan was adopted in 2013. The portion of the Aspen Hill Master Plan concerning the old Vitro property at Aspen Hill Road and Connecticut Avenue was rewritten in 2015 as the "Aspen Hill Minor Master Plan Amendment".


The goals of the 1964 General Plan focused on:

- Efficiency of land use
- Orderly conversion of undeveloped land to urban use
- Protection and development of natural resources
- Maintaining large open spaces
- Expanding outdoor recreation opportunities
- Public utilities and services
- Transportation system, including rapid transit
- Encouraging a greater variety of living environments through new towns and residential clusters (with an emphasis on the I-270 and I-95 corridors)
- Encouraging imaginative urban design

Specialized County-Wide Master Plans


In recent years, the County Council has adopted a number of specialized county-wide master plans, including the Technical Update to the Master Plan of Highways and Transitways, the Bicycle Master Plan, the Energized Public Spaces Functional Master Plan, and the Countywide Transit Corridors Functional Master Plan. Preliminary work on a possible Georgia Avenue Corridor Master Plan was begun many years ago, but appears to be on indefinite hold (a master plan for the Veirs Mill Road corridor was adopted in 2019). The Planning Board is currently working on drafting a county-wide Pedestrian Master Plan, which they hope to propose to the County Council by December.

Zoning in Strathmore Bel Pre

Most of the land in Strathmore Bel Pre is zoned either R-90 or R-200. These two zones are one-family residential zones with a minimum lot size of 9,000 square feet or 20,000 square feet, respectively. Strathmore Bel Pre Section 12 (the townhomes on St. Helen Circle and Trillium Terrace) are zoned R-200/TDR (a Transferable Development Rights overlay zone) which allows denser development of the property in exchange for a property owner in the County's Agricultural Reserve (which makes up most of the northern third of the County) agreeing not to fully develop their land.

Too Many Single Family Homes?

A major thrust of the proposed *Thrive Montgomery 2050* plan is the Planning Board's conclusion that there is too much single family housing in Montgomery County as compared to other types of housing. It should be noted that this conclusion was originally generated pre-pandemic, before telework and teleschooling, which now appears to be driving families towards larger, single family housing. One possible implementation of what the Planning Board sees as a major problem (too many single family homes) would be to take large amounts of land currently zoned for single family homes and rezoning those to zones that allow (or require) multi-family homes.



Missing Middle Housing

Another approach would be to change the definitions in the County Zoning Ordinance so that zones that currently focus on single family housing would now allow multi-family housing. The Planning Board identifies these multi-family homes as Montgomery County's "missing middle housing", including "2-to-4 story multi-unit clustered housing such as smaller townhouses, duplexes, triplexes, quadraplexes, detached courtyard cottages, attached courtyard apartments, or smaller apartment buildings (typically with fewer than 20 units)." More details can be found in the Planning Board's September 2018 Missing Middle Housing Study, which is available from the Planning Board at montgomerypanning.org/planning/housing/.


Access to the Plans and the Upcoming County Council Public Hearings on Thrive 2050




