COMMUNITY PARKING ISSUE

Much of the meeting was a call with community members (27 attendees) to discuss the parking issues on some of our neighborhood streets. Excessive parking by non-community members on Blue Spruce and Bluff Point is causing an issue for the residents of those streets. The vehicles are mostly white vans, which block the driveways and cause unsafe conditions at corners. This also creates a noise situation early in the morning and late in the evening as the vans arrive and leave. Additionally, trash is being left behind by the van owners.

Alison Smith of Blue Spruce petitioned residents on Blue Spruce for their support for residential parking permits for the street. She sent the results on the SBPCA Board, and they were forwarded to the County. Momentum was lost as offices closed for COVID-19, so no further action was taken at that time.

The request was subsequently resent to the DOT, where the case was assigned to an inspector. The petition will be reviewed and investigated, and we were told we should expect an answer by May 3, 2021. We have not received any information to date, and Nancy will follow up with them if we do not receive a response by the due date.

Rules and regulations of permitting process usually address parking during the day and parking on streets near metro stations. Our problem is the opposite. Our problem is with overnight parking.

The group spent some time brainstorming possible solutions:

Can the overflow vehicles use the parking lot of the Church on the corner of Hewitt and Georgia Avenues? The parking low is part of the Matthew Henson Greenway

What about the Bel Pre school parking lot? (Overflow cars from the townhouses on Beaverwood use Strathmore ES parking lot overnight).

Should we participate in these discussions or let the apartment and condo management lead?

We will get together again after the County responds to our request. This portion of the call adjourned at 8:30 pm.

We will hold a virtual town hall at 7:30 pm on April 27, 2021, to discuss the parking issues on Hewitt Avenue, Bluff Point, Blue Spruce and Beaverwood.

It seems there are numerous vehicles parking on our neighborhood streets, causing disturbances and possible safety issues. The problem was identified last year, and the Board sent a request for a hearing to the Montgomery County Traffic Operations. They received our request but did not respond. We did not pursue the matter at that time.

Our next step is to see if we qualify for a public hearing. To that end, Nancy will contact the MCDOT and ask if they will attend our virtual meeting to talk about the permitting process. If there is interest on the part of the community, possibly some residents will step up to lead the initiative. Alison Smith, one of our residents in that area, spearheaded the initial request last year and circulated a petition for signatures.

Library

There will be a virtual meeting on March 24 to demonstrate applications used by the Library to reserve and read books. The call will include how to use Overdrive and Libby and some other applications. Information to register for the virtual meeting will be on the listserv. Once you register, a link will be sent to you.
