## PRESENTATION - THE BUGLE

The Board had previously discussed ways in which to reduce the cost of producing The Bugle quarterly, become more environmentally responsible and to streamline the distribution process. A survey prepared last year indicated that a majority of community members would prefer an electronic Bugle rather than paper. The subject was brought up at the December Community Meeting and Trisha Wells volunteered to champion this effort.

Trisha prepared a high-level presentation for the Board on her thoughts and ideas for transitioning The Bugle to electronic delivery.

# Concept:

- The default is paper
- · Obtain permission from owners to "opt-in" for electronic delivery
- Maintenance of delivery database
  - Invite new owners
  - o Provide option to change delivery mode
  - Prevent renters from opting out
- Provide delivery instructions to Bugle delivery team with each publication
- Convert The Bugle into blog-style publication and distribute via email to owners who opt in
- Chris Jennison has confirmed we could create pop-up ads for the advertisers within the articles.
- "Opt in" would be handled through Google Forms

Discussion followed Trisha's presentation and covered details of the concept, including, work effort, ongoing maintenance, responsibilities, cost, technology, and impact on community and advertisers.

Trisha will present this idea to the BPRA at their next meeting.

Trisha has other commitments for the next few months. During that time, we will discuss the concept and determine how/whether to proceed.

In order to successfully implement a more electronic solution to delivery of The Bugle, procedures would need to be developed to:

- Allow members of the community to choose which format(s) they want to receive The Bugle in recognizing that some community members may want to receive The Bugle in more than one format;
- How to maintain the list of which formats go to which community members;
- Keeping track of when members of the community leave and when new members of the community arrive and integrating this into the list;
- Treatment of renters versus owners:
- Making sure that advertisers' interests are protected;

- Providing the distributors of the paper version of The Bugle with a method of letting them know which
  houses to provide the paper version, that will not increase the workload of the distributors; and
