Recreational Facilities Policies

Section 216: Summer Entertainment Series and Summer Community Affairs Forum Series

Members of the Strathmore Bel Pre Community attending programs that are part of the Summer Entertainment Series or the Summer Community Affairs Forum Series will be treated as guests of the Board of Trustees for those programs and do not need to be accompanied by a member at the front desk. This guest status only applies to the program and does not include pool privileges.

Elliot will find out whether 'guests of the Board of Trustees' can bring guests. Currently, if a BPRA member invites a guest, there is a \$4 fee that applies.

John made a motion, which was seconded and passed, that Civic Association request the BPRA to modify the rules under Section 216 of the Recreational Facilities Policies, to reinstate the guest policy that was in effect in 2019, which allowed that residents and Civic Association members could bring any number of guests for no fee to the Summer Entertainment Series and the Community Forums, with the additional verbiage that the resident should provide a list of the guests to the front desk.
